

Non-renouncable Entitlements Issue - Extension of Closing Date

On 14 July 2015, Pacific Niugini Limited (ACN 003 207 467) (ASX Code: PNR) (the Company) announced a non-renounceable entitlement issue of one (1) fully paid ordinary share in the capital of the Company (Share) for every four (4) shares held by shareholders on 21 July 2015 (Record Date) at an issue price of \$0.05 per Share to raise up to \$4,905,674 before costs (Rights Issue). The Rights Issue includes one attaching option for every two (2) shares subscribed, with an exercise price of \$0.06 and expiry date two years after issue, and an offer of any entitlements issues shortfall at the same issue price for Shares under the Rights Issue (Shortfall Offer) (the Offers).

As the pace of progress at the Nicolsons Project is advancing rapidly, and due to the recent excellent results announced on 23 July 2015, the Company wishes to ensure that all shareholders have an adequate opportunity to participate in the Offers.

A number of shareholders have indicated difficulty in meeting the issue timeline. The Company has received requests to extend the closing date of the Rights Issue Offer to enable more shareholders to participate and accordingly the directors have resolved to extend the closing date of the Rights Issue Offer until 5.00pm (WST) on Friday 14 August 2015.
