### **Clarification of results – Garaina**

As you are aware, Pacific Niugini Limited released a number of costean sample, and continuous rock chip samples on the 4<sup>th</sup> of July 2011.

The results reported reflect what the company views as being the most significant continuous intercepts within the long costeans excavated to date. As would be expected, samples have been excavated across mineralized zones as topography allows, and as such a number of samples exist outside of the strongly mineralised envelopes reported.

Only mineralized envelopes with an average grade in excess of 2g/t Au, and of potentially minable width were reported, and the intervals were calculated by taking the weighted average grade of both Au and Ag over the selected interval. In all cases, intervals of low-grade mineralisation occur within the high-grade envelope. The low-grade intervals are included in the overall weighted average grade of the reported mineralised envelopes.

With regard to the continuous rock chip samples collected in the newly identified copper rich zone, these samples were the only 4 samples collected in a reconnaissance visit to the magnetic high area indicated below. The chip samples were taken across a one metre interval at four locations within the area indicated. There area of magnetic high appears to be approximately 300m in diameter.

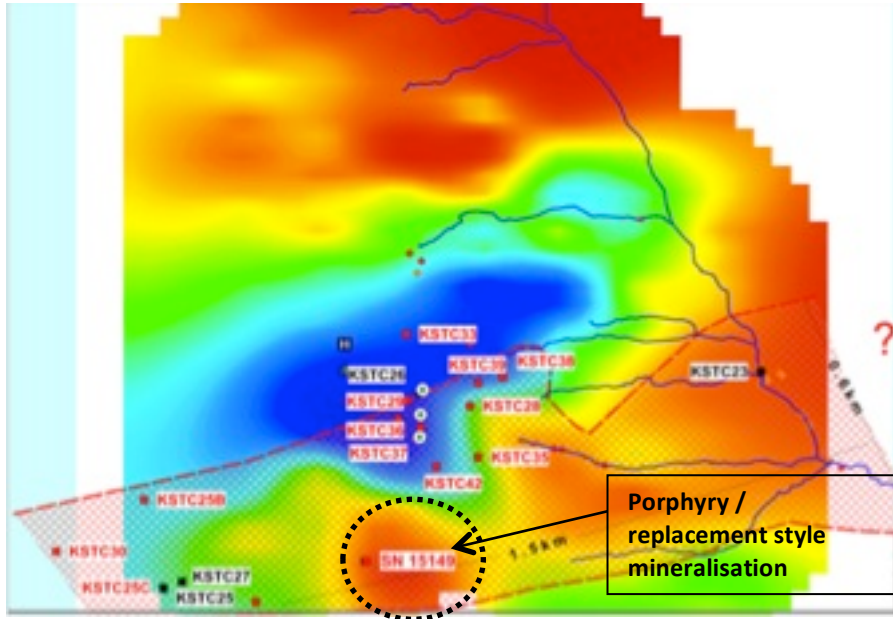
