## 1. CHAIRMAN'S LETTER

Dear Shareholders

### Entitlement Issue Offer

This Prospectus outlines the details of a pro-rata non-renounceable entitlement offer to Shareholders of Pacific Niugini Ltd (**Company**) on the basis of one (1) Share for every four (4) Shares held by those shareholders registered at the Record Date at an issue price of \$0.05 per Share to raise approximately \$4,905,674 (before costs of the issue). The Offer includes one attaching two year option for every two (2) shares subscribed for, with an exercise price of \$0.06.

Proceeds of the Entitlement Offer and Shortfall Offer will be applied to development activity at the Nicolson's Gold Mine and enhance the Company's balance sheet as we move towards first gold production. See section 7.1 for details of the intended use of proceeds raised from the entitlement offer (which assumes maximum subscription).

This Prospectus and personalised Entitlement and Acceptance Form should be read carefully and in their entirety before deciding whether or not to participate in the Offer. In particular Eligible Shareholders should consider the key risk factors outlined in this Prospectus. Eligible Shareholders can, in addition to their Entitlement, also apply for Shortfall Securities regardless of the size of their present holding and other investors can apply for Shortfall Securities after the Closing Date.

On behalf of your Board, I invite you to consider this investment opportunity to participate in the Company's growth and exciting transition from developer to producer, with first gold production at the Nicolson's Gold Mine anticipated in late 2015.

## 5. KEY INVESTMENT HIGHLIGHTS AND INVESTMENT RISKS

---

### 5.1 Key Investment Highlights

- Pacific Niugini has re-developed the Nicolsons Gold Mine and CIP processing plant near Halls Creek in Western Australia. The mine has all required approvals and infrastructure in place and underground mining operations are underway.
- The Nicolsons Gold Mine is one of few new gold mine developments underway in Australia, with first gold production expected in August 2015 and full production expected before the end of 2015. An initial 4 year mine production plan is in place with exploration planned to seek to increase the current gold resource.
- Production plant with 150,000 tonne per annum name plate capacity, and option for expansion to approximately 200,000 tonnes per annum.
- Diamond drilling during 2014 produced very high grade intercepts including **1.2m @ 103.0 g/t, 3m @ 20.4g/t and 3.4m @ 13.2 g/t and 2.0m @ 43.4 g/t** (ref ASX releases 16/9/2015 and 23/9/2015), demonstrating potential for very high grade zones resulting in the potential for increased production. Mineralisation occurs over a strike length of approximately 700m and is open at depth and along strike.
- The Nicolsons resource is only drilled to approximately 300m below surface, with high grade results at the base of drilling. Drilling results show the resource to be open along strike and at depth, and Pacific Niugini intends to undertake exploration drilling from underground platforms to seek to extend the resource and life of the mine.
- Additional JORC resources defined within 2km of Nicolsons at Wagtail and Rowdies deposits provide potential for additional mine feed.<sup>1</sup> A pipeline of exploration projects exist within current mining and exploration tenements with a number of immediate drilling targets.
- Pacific Niugini has retained 100% ownership of the exciting Garaina exploration project in Papua New Guinea, following termination of a joint venture arrangement with MGL Limited. The Garaina project has potential for discovery of large gold and copper-gold deposits with extensive geophysical, geochemical, and drilling data supporting the possible existence of a significant mineralised system. Pacific Niugini considers the project to hold considerable potential future value, and has entered into confidentiality agreements with several international and Australian companies with respect to potential joint venture arrangements to progress the project's development.

### 5.2 Key Investment Risks

- Mining at the Nicolsons Gold Mine is by underground methods which carry a number of risks which could affect the production or gold bearing ores. In particular, geotechnical risks could impact the overall mine plan, and zones of poor ground conditions have been encountered during the initial development of the mine. The existing processing plant has been extensively



refurbished during the mine construction, but is yet to be fully tested and commissioned, and unforeseen operational issues could arise.

- The development of Nicolson's Gold Mine has been funded through a gold pre-payment facility with the Commonwealth Bank of Australia (CBA). The facility contains banking covenants which are common in similar financing packages, but could result in the Company being in breach of its agreements with CBA if production and revenue requirements are not met. CBA holds first ranking security over the project.
- Gold resources and reserves are based on exploration data and modelling, and rely on the judgement of the qualified person producing the estimates. There is no guarantee that the estimated resources and reserves will be realised through mining.
- Exploration is speculative in nature, and there is no guarantee that additional exploration expenditure will result in expansion of existing known resources on the Company's projects.
- Operations in Papua New Guinea hold a number of additional risks compared with operations in Australia. Section 9 expands on Papua New Guinea risks. There is no guarantee that the Company will secure a new joint venture partner at Garaina in order to progress the project without substantial additional expenditure by the Company.

Fractional entitlements will be rounded up to the nearest whole number.

Based on the capital structure of the Company as at the date of this Prospectus (and assuming no Options are exercised, or Performance Rights or Convertible Notes converted, prior to the Record Date), a maximum of 98,113,481 Shares and 49,056,741 Options will be issued pursuant to this Offer to raise up to approximately \$4,905,674.

As at the date of this Prospectus the Company has 6,650,000 Options on issue. Existing holders of Options must exercise their Options prior to the Record Date in order to participate in the Entitlement Issue Offer. Please refer to section 7.4 of this Prospectus for information on the exercise price and expiry date of the Options on issue.

All of the Shares offered under this Prospectus will rank equally with the Shares on issue at the date of this Prospectus. Please refer to section 8 for further information regarding the rights and liabilities attaching to the Shares and the attaching Options.

The Entitlement Issue Offer is non-renounceable. Accordingly, a Shareholder may not sell or transfer all or part of their Entitlement.

The purpose of the Offers and the intended use of funds raised are set out in section 7.1 of this Prospectus.

### 6.4 Payment by BPAY®

The Directors reserve the right to issue the Shortfall at their discretion.

Any Entitlement not taken up pursuant to the Entitlement Issue Offer will form part of the Shortfall Offer.

## 7. PURPOSE AND EFFECT OF THE OFFERS

### 7.1 Purpose of the Offer

The purpose of the Offer is to raise approximately \$4,905,674 (assuming maximum subscription based on the total number of Shares on issue as at the date of this Prospectus and no Options are exercised, or Performance Rights or Convertible Notes convert, prior to the Record Date).

The funds raised from the Offer are planned to be used in accordance with the table set out below:

As with any budget, intervening events (including exploration success or failure) and new circumstances have the potential to affect the manner in which the funds are ultimately applied. The Board reserves the right to alter the way funds are applied on this basis. The Company's current cash resources and additional capital proposed to be raised by the Offer are sufficient to meet its current stated objectives.

The Company does not seek to raise a minimum amount under the Offers.

In the event that the Entitlement Issue Offer is not fully subscribed (and the Shortfall Offer is also not fully subscribed), the Company shall apply the proceeds of the Offers first towards the estimated expenses of the Offers, then towards the development of the Nicolsons Gold Mine with the balance (if any) applied towards general working capital. The Board reserves the rights to alter the priority in which funds raised are applied.

In the event that insufficient funds are raised to meet the expenses of the Offer, the Company intends to use its existing working capital to meet the expenses of the Offers.

### 7.2 Effect of the Offers

The principal effect of the Offers, assuming all Entitlements are accepted and no Options are exercised or Performance Rights or Convertible Notes convert prior to the Record Date, will be to:

## **8. RIGHTS AND LIABILITIES ATTACHING TO SECURITIES**

---

### **8.1 Shares**

The following is a summary of the more significant rights and liabilities attached to Shares being offered pursuant to this Prospectus. This summary is not exhaustive and does not constitute a definitive statement of the rights and liabilities of Shareholders. To obtain such a statement, persons should seek independent legal advice.

Full details of the rights and liabilities attaching to Shares are set out in the Constitution, a copy of which is available for inspection at the Company's registered office during normal business hours.

#### **General meetings**

Shareholders are entitled to be present in person, or by proxy, attorney or representative to attend and vote at general meetings. Shareholders may requisition meetings in accordance with section 249D of the Corporations Act and the Constitution.

#### **Voting rights**

Subject to any rights or restrictions for the time being attached to any class or classes of shares, at general meetings of Shareholders or classes of shareholders:

- (a) each Shareholder entitled to vote may vote in person or by proxy, attorney or representative;
- (b) on a show of hands, every person present who is a Shareholder or a proxy, attorney or representative of a Shareholder has one (1) vote; and
- (c) on a poll, every person present who is a Shareholder or a proxy, attorney or representative of a Shareholder shall, in respect of each Share held by him, or in respect of which he is appointed a proxy, attorney or representative, have one (1) vote for each Share held.

#### **Dividend rights**

Subject to the rights of any preference shareholders and to the rights of the holders of any shares created or raised under any special arrangement as to dividend, the Directors may from time to time declare a dividend to be paid to the Shareholders entitled to the dividend which shall be payable on all shares according to the proportion that the amount paid (not credited) is of the total amounts paid and payable (excluding amounts credited) in respect of such shares.

The Directors may from time to time pay to the Shareholders any interim dividends as they may determine. The Directors may set aside any amounts that they may determine as reserves, to be applied at the discretion of the Directors, for any purpose for which the Company's profits may be properly applied.

Subject to the ASX Listing Rules and the Corporations Act, the Company may, by resolution of the Directors, implement a dividend reinvestment plan on such terms and conditions as the Directors think fit and that provides for any dividend which the Directors may declare from time to time payable on shares which are participating shares in the dividend reinvestment plan, less any amount which the Company shall either pursuant to the Constitution or any law be entitled or obliged to retain, be applied by the Company to the payment of the subscription price of Shares.

## **Winding-up**

If the Company is wound up, the liquidator may, with the authority of a special resolution, divide among the Shareholders in kind the whole or any part of the Company's property, and may for that purpose set such value as he considers fair upon any property to be so divided, and may determine how the division is to be carried out as between the Shareholders or different classes of shareholders.

## **Shareholder liability**

As the Shares issued will be fully paid shares, they will not be subject to any calls for money by the Directors and will therefore not become liable for forfeiture.

## **Transfer of Shares**

Generally, Shares in the Company are freely transferable, subject to formal requirements, the registration of the transfer not resulting in a contravention of, or failure to observe the provisions of, a law of Australia and the transfer not being in breach of the Corporations Act and the ASX Listing Rules.

## **Future increase in capital**

The issue of any new Shares is under the Directors' control. Subject to restrictions on the issue or grant of securities contained in the ASX Listing Rules, the Constitution and the Corporations Act (and without affecting any special right previously conferred on the holder of an existing share or class of shares), the Directors may issue Shares as they shall, in their absolute discretion, determine.

## **Variation of rights**

Under section 246B of the Corporations Act, the Company may, with the sanction of a special resolution passed at a meeting of Shareholders, vary or abrogate the rights attaching to Shares.

If at any time the share capital is divided into different classes of shares, the rights attached to any class (unless otherwise provided by the terms of issue of the shares of that class), whether or not the Company is being wound up, may be varied or abrogated with the consent in writing of the holders of three quarters of the issued shares of that class, or if authorised by special resolution passed at a separate meeting of the holders of the shares of that class.

## **Alteration of Constitution**

In accordance with the Corporations Act, the Constitution can only be amended by a special resolution passed by at least three quarters of Shareholders present and voting at a general meeting. In addition, at least 28 days written notice specifying the intention to propose the resolution as a special resolution must be given.

## **8.2 Options**

The terms and conditions of the Options offered pursuant to this Prospectus are set out below.

### **Entitlement**

Each Option entitles the holder to subscribe for one Share upon exercise of the Option.

### **Exercise Price**

The amount payable upon exercise of each Option will be \$0.06 (**Exercise Price**).

### **Expiry Date**

Each Option will expire at 5:00 pm (WST) two years after their issue date (**Expiry Date**). An Option not exercised before the Expiry Date will automatically lapse on the Expiry Date.

### **Exercise Period**

The Options are exercisable at any time on or prior to the Expiry Date (**Exercise Period**).

### **Notice of Exercise**

The Options may be exercised during the Exercise Period by notice in writing to the Company in the manner specified on the Option certificate (Notice of Exercise) and payment of the Exercise Price for each Option being exercised in Australian currency by electronic funds transfer or other means of payment acceptable to the Company.

### **Exercise Date**

A Notice of Exercise is only effective on and from the later of the date of receipt of the Notice of Exercise and the date of receipt of the payment of the Exercise Price for each Option being exercised in cleared funds (**Exercise Date**).

### **Timing of issue of Shares on exercise**

Within 15 Business Days after the Exercise Date, the Company will:

- (i) allot and issue the number of Shares required under these terms and conditions in respect of the number of Options specified in the Notice of Exercise and for which cleared funds have been received by the Company; and
- (ii) if admitted to the official list of ASX at the time, apply for official quotation on ASX of Shares issued pursuant to the exercise of the Options.

### **Shares issued on exercise**

Shares issued on exercise of the Options rank equally with the then issued shares of the Company.

### **Quotation of Shares issued on exercise**

If admitted to the official list of ASX at the time, application will be made by the Company to ASX for quotation of the Shares issued upon the exercise of the Options.

### **Reconstruction of capital**

If at any time the issued capital of the Company is reorganised or reconstructed, all rights of an Optionholder are to be changed in a manner consistent with the Corporations Act and the ASX Listing Rules at the time of the reorganisation or reconstruction.

**Participation in new issues**

There are no participation rights or entitlements inherent in the Options and holders will not be entitled to participate in new issues of capital offered to Shareholders during the currency of the Options without exercising the Options.

**Change in exercise price**

An Option does not confer the right to a change in Exercise Price or a change in the number of underlying securities over which the Option can be exercised.

**Transferability**

The Options are transferable subject to any restriction or escrow arrangements imposed by ASX or under applicable Australian securities laws.

## **9. RISK FACTORS**

---

### **9.1 Introduction**

The Securities offered under this Prospectus are considered highly speculative. An investment in the Company is not risk free and the Directors strongly recommend potential investors to consider the risk factors described below, together with information contained elsewhere in this Prospectus and to consult their professional advisers before deciding whether to apply for Securities pursuant to this Prospectus.

There are specific risks which relate directly to the Company's business. In addition, there are other general risks, many of which are largely beyond the control of the Company and the Directors. The risks identified in this section, or other risk factors, may have a material impact on the financial performance of the Company and the market price of the Securities.

The following is not intended to be an exhaustive list of the risk factors to which the Company is exposed.

### **9.2 Investment Specific Risks**

#### **(a) Stock market fluctuations and economic conditions**

The Shares to be issued under this Prospectus will be quoted on the ASX. The price of Securities may rise or fall and there is no guarantee in respect of profitability, dividends, return of capital, or the price at which the Securities may trade on the ASX.

The value of the Securities will be determined by the stock market and will be subject to a range of factors beyond the control of the Company, and the Directors and officers of the Company. Such factors include, but are not limited to:

- (a) the demand for and availability of Shares;
- (b) movements in domestic interest rates;
- (c) exchange rates;
- (d) general and domestic economic activity; and
- (e) fluctuations in the Australian and international stock markets.

Returns from an investment from the Securities may also depend on general stock market conditions as well as the performance of the Company. There can be no guarantee that there will be an active market in the Securities.

Changes in economic and business conditions or government policies in Australia or internationally may affect the fundamentals which underpin the projected growth of the Company's target markets or its cost structure and profitability. Adverse changes in such things as the level of inflation, interest rates, exchange rates, government policy (including fiscal, monetary and regulatory policies), consumer spending and employment rates, amongst others, are out of the control of the Company and may result in material adverse impacts on the business or its operating results.

**(b) Dilution risk**

Upon completion of the Offers (assuming the Offers are fully subscribed) and no Options are exercised, and no Performance Rights or Convertible Notes convert, prior to the Record Date) the number of Shares in the Company will increase from 392,453,924 currently on issue to 490,567,405 and current Shareholders that do not participate in the Offer would have their holdings diluted by approximately 20%. In the event any Options are exercised (including Options issued pursuant to this Prospectus or on conversion of Convertible Notes) or any Performance Rights or Convertible Notes convert current Shareholders will be further diluted.

**(c) Liquidity of Securities**

There may be relatively few potential buyers or sellers of the Securities on the ASX at any time. This may increase the volatility of the price of the Securities. It may also affect the prevailing market price at which Shareholders are able to sell their Securities. This may result in a market price being received which is less than the price that Shareholders paid to acquire their Securities.

**(d) Taxation**

The acquisition and disposal of Securities will have tax consequences, which will differ depending on the individual financial affairs of each investor. All potential investors in the Company are urged to obtain independent financial advice about the consequences of subscribing for Securities from a taxation viewpoint and generally.

To the maximum extent permitted by law, the Company, its officers and each of their respective advisers accept no liability and responsibility with respect to the taxation consequences of subscribing for Securities under this Prospectus.

**9.3 Company Specific Risks**

**(a) Operations in Halls Creek**

The Company is currently developing its 80% owned Nicolsons Gold Mine near Halls Creek. The 20% owner of the project is Bulletin Resources Limited (**Bulletin**). The Company and Bulletin are operating as an unincorporated joint venture.

As of the date of this Prospectus, the Company owns 80% of the Nicolsons Gold Mine and both companies are contributing to development of the project in accordance with their equitable share. There is no guarantee that Bulletin will be able to continue funding their 20% share of the project.

To date the mine development has been funded using a gold pre-payment facility provided by the Commonwealth Bank of Australia (CBA). CBA holds various security rights over the project, the 100% owned operating subsidiary (Halls Creek Mining Pty Ltd), Pacific Niugini Limited and Bulletin Resources Limited. The Halls Creek Mining and Bulletin pre-payment facilities are separate and do not prejudice the rights of each other.

**(b) Development activity at Nicolsons Gold Mine**

The decline development at Nicolsons Gold Mine has traversed random and un-anticipated zones of poor quality, partially oxidized ground which

has resulted in slower than anticipated progress and additional cost to support. Based on current planning, and assuming that anticipated ground conditions are encountered, the Company expects to intersect first ore shortly and intends and intends to commence processing ore on a campaign basis in August 2015. Full production is expected to be achieved in late 2015.

This delay in accessing the first ore levels is likely to impact expected revenue from gold sales during the early months of operation. If the Company continues to experience difficult ground conditions, the Company may experience further delays and may require additional funding prior to self funding operations.

**(c) Finance Package with Commonwealth Bank of Australia**

The Company has a gold pre-pay facility with the CBA of an amount of 6,560 ounces of gold. The facility includes certain covenants including that the Company must maintain a minimum level of cash. Based on project development plans at the Nicolson's Gold Mine, and risk of future delays, there is the risk that the Company may breach covenants of the facility, in the absence of any further equity funding. If there is a breach of covenants, there is a risk that CBA will exercise its right to require repayment of the facility and enforce its security.

**(d) Additional requirements for capital**

The Company's capital requirements depend on numerous factors. Depending on the Company's ability to generate income from its operations, the Company may require further financing in addition to amounts raised under the Offer. Any additional equity financing will dilute shareholdings, and debt financing, if available, may involve restrictions on financing and operating activities. If the Company is unable to obtain additional financing as needed, it may be required to reduce the scope of its operations and scale back its exploration programmes as the case may be. There is however no guarantee that the Company will be able to secure any additional funding or be able to secure funding on terms favourable to the Company.

**(e) Exploration success**

The continuing future profitability of the Company and the value of its securities are directly related to the results of exploration. The exploration tenements held by the Company are at various stages of exploration and potential investors should understand that mineral exploration and development are high-risk undertakings. There can be no assurance that exploration of these tenements, or any other tenements that may be acquired in the future, will result in discovery of an economic ore deposit. Even if an apparently viable deposit is identified, there is no guarantee that it can be economically exploited.

The Company's future exploration activities may be affected by a range of factors including geological conditions, limitations on activities due to seasonal weather patterns, unanticipated operational and technical difficulties, industrial and environmental accidents, native title process, changing government regulations and many other factors beyond the Company's control.

The Company's success will also depend upon the Company having access to sufficient development capital, being able to maintain title to its



tenements and obtaining all required approvals for its activities. In the event that exploration programs prove to be unsuccessful, this could lead to diminution in the value of the Company's tenements, a reduction in the cash reserves of the Company and possible relinquishment of tenements.

The Company's exploration costs are based on certain assumptions with respect to the method and timing of exploration. By their nature, these estimates and assumptions are subject to significant uncertainties and, accordingly, the actual costs may be materially different to these estimates and assumptions. Accordingly, no assurance can be given that the cost estimates and the underlying assumptions will be realised in practice, which may materially and adversely affect the Company's viability.

**(f) Resource estimates**

Any resource estimates that have been released by the Company now or will be released in the future will be expressions of judgement based on knowledge, experience and industry practice. Estimates which are valid when originally calculated may alter significantly when new information or techniques become available. In addition, by their very nature, resource estimates are imprecise and depend to some extent on interpretation, which may prove to be inaccurate. As further information becomes available through additional fieldwork and analysis, the estimates are likely to change. This may result in alterations to development and mining plans which may, in turn, adversely affect the Company's operations.

**(g) Gold operating and development risks**

The Company's ability to achieve any production, development, operating cost and capital expenditure estimates in a timely basis cannot be assured. The business of gold mining involves many risks and may be impacted by factors including ore tonnes, yield, input prices (some of which are unpredictable and beyond the Company's control), overall availability of free cash to fund continuing development activities, labour force disruptions, cost overruns, change in the regulatory environment and other unforeseen contingencies.

Other risks also exist such as environmental hazards (including discharge of pollutants or hazardous chemicals), variation in geotechnical conditions, industrial accidents and occupational and health hazards. Such occurrences could result in damage to, or destruction of, production facilities, personal injury or death, environmental damage, delays in mining, increased production costs and other monetary losses and possible legal liability to the owner or operator of a mine. The Company may become subject to liability for pollution or other hazards against which it has not insured or cannot insure, including those in respect of past mining activities in an area for which it was not responsible.

The risks outlined above also mean that there can be no assurances as to the ongoing mining operations of the company in relation to any of the Company's projects or which the Company may acquire in the future.

**(h) Gold price volatility**

If the Company achieves exploration success leading to gold production, the Company's financial performance will be sensitive to the spot gold price. The gold price is affected by numerous factors and events that are beyond the Company's control. These factors and events include general economic activity, world demand, forward selling activity, gold reserve

movements at central banks, cost of production by the gold producers and other matters such as inflationary expectations, interest rates, currency exchange rates (particularly the strength of the US dollar) as well as general global economic conditions and political trends.

If the gold price should fall below or remain below the Company's costs of production for any sustained period due to these or other factors and events, the Company's exploration and production could be delayed or even abandoned. A delay in exploration or production or the abandonment of one or more of the Company's projects may require the Company to write-down any gold reserves and may have a material adverse effect on the Company's production, earnings and financial position.

**(i) Infrastructure and transport**

As outlined above, the Company is not currently in production. If production does commence, the Company's ability to achieve production targets, receive goods and services and export products may be restricted by access to power networks, roads and other infrastructure.

**(j) Reliance on key personnel**

The responsibility of overseeing the day-to-day operations and the Company's strategic management depends substantially on its senior management and key personnel. There can be no assurance given that there will be no detrimental impact on the Company if one or more of these employees cease their employment.

**(k) Acquisition risk**

The Company's objectives include the pursuit of new projects in the resources sector, by way of acquisition or investment. The Directors will use their expertise and experience in the resources sector to assess the value of potential projects that have characteristics that are likely to provide returns to Shareholders. There can be no guarantee that any new project acquisition or investment will eventuate from these pursuits, or that any acquisitions will result in a return for Shareholders.

**(l) Operations in Papua New Guinea**

Some of the Company's projects are located in Papua New Guinea and the Company is subject to the risks associated with operating in that country, including various levels of political, economic, social and other risks and uncertainties.

These risks and uncertainties include but are not limited to the risk of civil unrest, terrorism, expropriation and nationalization, renegotiation or nullification of existing concessions, licences, permits or contracts, illegal mining, changes in taxation policies, changing political conditions, currency inflation, currency controls and governmental regulations that favour or require minimum levels of ownership by Papua New Guinean residents.

Changes, if any, in mining or investment policies, or shifts in political attitude, in Papua New Guinea may adversely affect the operations or profitability of the Company. Operations may be affected in varying degrees by government regulations with respect to, but not limited to, restrictions on production, price controls, export controls, foreign currency remittance, income taxes, expropriation of property, foreign investment, maintenance of claims, environmental legislation, land use claims of local people, water use and mine safety.

The Papua New Guinean government retains the right to take a 30% contributing ownership stake in mining projects in the country under the provisions of the Mining Act (1992).

Local land groups in Papua New Guinea are recognised as the owners of the land, and land use agreements are required prior to commencement of mining. Negotiation of such agreements can be both time consuming and expensive.

Failure by the company to comply strictly with applicable laws, regulations and local practices relating to mineral rights applications and tenure, could result in loss, reduction or expropriation of entitlements, or the imposition of additional local or foreign parties as joint venture partners with carried or other interests.

The Company's operations in Papua New Guinea may also be adversely affected by laws and policies of Australia affecting foreign trade, taxation and investment. In the event of a dispute arising in connection with its operations in Papua New Guinea, the Company may be subject to the exclusive jurisdiction of foreign courts or may not be successful in subjecting foreign persons to the jurisdiction of courts in Australia or enforcing Australian judgements in foreign jurisdictions.

Papua New Guinea has reported risks for personal safety and security in various locales with high crime rates which could affect operations unless appropriately managed. The Australian Department of Foreign Affairs and Trade provide travel advice at <http://www.smarttraveller.gov.au>, and advise travellers to exercise a high degree of caution.

The Company has executed a number of confidentiality agreements with respect to potential partnerships in the Garaina Project following termination of an agreement with MGL Limited in 2015.

The Company's Bulolo project (including ML457 and EL1616) is the subject of an existing joint venture with PNG Forest products (**PNGFP**), and there is no guarantee that PNGFP will meet their obligations. The project has been the subject of negotiations with respect to possible divestment, and the Company may seek to divest ML457. If sold, the company would not receive future benefits from the project. The Company is taking steps to relinquish its interest in EL1616 in the near term.

The occurrence of these various factors and uncertainties cannot be accurately predicted and could have an adverse effect on the operations or profitability of the Company. The Company has made its investments and strategic decisions based on the information currently available to the Directors, however should there be any material change in the political, economic, legal and social environments in Papua New Guinea, the Directors may reassess investment decisions and commitments to assets in Papua New Guinea.

## **9.4 Industry Specific Risks**

### **(a) Environmental**

The Company's operations and proposed activities in Australia and Papua New Guinea are subject to state and federal laws and regulations concerning the environment. As with most exploration projects and mining operations, the Company's activities are expected to have an impact on the environment, particularly if advanced exploration or mine development

proceeds. It is the Company's intention to conduct its activities to the highest standard of environmental obligation, including compliance with all environmental laws.

Mining operations have inherent risks and liabilities associated with safety and damage to the environment and the disposal of waste products occurring as a result of mineral exploration and production. The occurrence of any such safety or environmental incident could delay production or increase production costs. Events such as unpredictable rainfall or bushfires may impact on the Company's ongoing compliance with environmental legislation, regulations and licences. Significant liabilities could be imposed on the Company for damages, clean-up costs or penalties in the event of certain discharges into the environment, environmental damage caused by previous operations or non-compliance with environmental laws or regulations.

The disposal of mining and process waste and mine water discharge are under constant legislative scrutiny and regulation. There is a risk that environmental laws and regulations will become more onerous making the Company's operations more expensive.

Approvals are required for land clearing and for ground disturbing activities. Delays in obtaining such approvals can result in the delay to anticipated exploration programs or mining activities.

**(b) Tenure risks and native title**

Interest in tenements in Australia is governed by the respective state legislation and is evidenced by the granting of licences or leases. Each licence or lease is for a specific term and carries with it annual expenditure and reporting commitments, as well as other conditions requiring compliance. Consequently, the Company could lose title to or its interest in tenements if licence conditions are not met or if insufficient funds are available to meet expenditure commitments.

It is also possible that, in relation to tenements which the Company has an interest in or will in the future acquire such an interest, there may be areas over which legitimate common law native title rights of Aboriginal Australians exist. If native title rights do exist, the ability of the Company to gain access to tenements (through obtaining consent of any relevant landowner), or to progress from the exploration phase to the development and mining phases of operations may be adversely affected. The Directors will closely monitor the potential effect of native title claims involving tenements in which the Company has or may have an interest.

**(c) Safety legislation**

Current and future mines are subject to a range of safety legislation which may change in a manner that may include requirements in addition to those now in effect, and a heightened degree of responsibility for companies and their directors and employees.

**(d) Industry and commodity cycles**

The demand for, and price of, metals is highly dependent on a variety of factors, including international supply and demand, actions taken by governments, and global economic and political developments. Adverse changes in market sentiment or conditions can and will impact the Company's ability to manage operating costs and have future sales meet

installed production capacity. These impacts could lead to a reduction in earnings and the carrying value of assets that are outside of the Company's control.

**(e) Impact of inflation on costs**

Higher than expected inflation rates generally, or specific to the mining industry in particular, could be expected to increase operating and development costs and potentially reduce the value of future project developments.

**9.5 General Risks**

**(a) Investment risks**

As with any stock market investment, there are various risks associated with investing in the Company, specifically because of the nature of the Company's exploration business and the present stage of development of the Company's operations. Potential investors should consider whether the Securities offered under this Prospectus are a suitable investment having regard to their own personal investment objectives and financial circumstances and the risk factors set out in this section. Many of these risk factors are outside the Directors' control. Whilst some common risk factors are set out in this section, it is not possible to produce an exhaustive list. The Directors recommend that potential investors consult their professional advisers before deciding whether to apply for Securities.

**(b) Adverse changes to government policy and taxation**

Changes in relevant taxation laws, interest rates, other legal, legislative and administrative regimes, and government policies, may have an adverse effect on the assets, operations and ultimately the Company's financial performance. These factors may ultimately affect the Company's financial performance and the market price of the Securities.

**(c) Insurance risks**

The Company's operations are insured in accordance with industry practice however in certain circumstances, the Company's insurance may not be of a nature or level to provide adequate insurance cover. The occurrence of an event that is not covered or not fully covered by insurance could have a material adverse effect on the business, financial condition and results of the Company.

Insurance against all risks associated with mining exploration and production is not always available and where available the costs can be prohibitive.

**(d) Claims, liability and litigation**

Although the Company is not currently involved in any legal proceedings and the Directors are not aware of any legal proceedings pending or threatened against the Company, the risk of litigation remains a general risk to the Company. The Company may incur costs in making payments to settle any such claims which may not be adequately covered by insurance or at all. Such payment may have an adverse impact on the Company's profitability and/or financial position.

**(e) Competition risk**

The industry in which the Company is involved is subject to domestic and global competition. Although the Company will undertake all reasonable due diligence in its business decisions and operations, the Company will have no influence or control over the activities or actions of its competitors, whose activities or actions may, positively or negatively, affect the operation and financial performance of the Company's projects and business.

**(f) Industrial action**

The Company is subject to the risk of industrial action and work stoppages by employees and contractors who provide services which are necessary for the continued operation of the Company's businesses.

**(g) Operating risks**

The operations of the Company may be affected by various factors including failure to achieve predicted grades in exploration and mining, operational and technical difficulties encountered in extraction, difficulties in commissioning and operating plant and equipment, mechanical failure or plant breakdown, unanticipated metallurgical problems which may affect extraction costs, adverse weather conditions, industrial and environmental accidents, industrial disputes and unexpected shortages or increases in the costs of consumables, spare parts, plant and equipment.

**9.6 Speculative investment**

The above list of risk factors ought not to be taken as exhaustive of the risks faced by the Company or by investors in the Company. The above factors, and others not specifically referred to above, may in the future materially affect the financial performance of the Company and the value of the Securities offered under this Prospectus.

Therefore, the Securities to be issued pursuant to this Prospectus carry no guarantee with respect to the payment of dividends, returns of capital or the market value of those Securities.

Potential investors should consider that investment in the Company is speculative and should consult their professional advisers before deciding whether to apply for Securities under this Prospectus.

## **10. ADDITIONAL INFORMATION**

### **10.1 Litigation**

As at the date of this Prospectus, the Company is not involved in any legal proceedings and the Directors are not aware of any legal proceedings pending or threatened against the Company.

### **10.2 Continuous disclosure obligations and documents available for inspection**

The Company is a “disclosing entity” (as defined in section 111AC of the Corporations Act) for the purposes of section 713 of the Corporations Act and, as such, is subject to regular reporting and disclosure obligations. Specifically, like all listed companies, the Company is required to continuously disclose any information it has to the market which a reasonable person would expect to have a material effect on the price or the value of the Company’s securities.

This Prospectus is a “transaction specific prospectus”. In general terms a “transaction specific prospectus” is only required to contain information in relation to the effect of the issue of securities on a company and the rights attaching to the securities. It is not necessary to include general information in relation to all of the assets and liabilities, financial position, profits and losses or prospects of the issuing company.

This Prospectus is intended to be read in conjunction with the publicly available information in relation to the Company which has been notified to ASX and does not include all of the information that would be included in a prospectus for an initial public offering of securities in an entity that is not already listed on a stock exchange. Investors should therefore have regard to the other publicly available information in relation to the Company before making a decision whether or not to invest.
